## **Parental Commitment to Riverside Christian School**

My signature indicates that I have read, understand, and agree with the Parental Commitment in making this application for my child to attend Riverside Christian School.

**Philosophy:** We have read / will read the Student/Parent Handbook and by signing this parental agreement, do pledge to support and cooperate in any way at home and at school to enhance and fulfill those ideals.

Parental Involvement: We understand the philosophy of the school cannot be fulfilled without parental involvement. Participation in Riverside Christian School's activities and fundraisers is needed. This involvement shall include, but is not limited to: participation in fundraising activities, attendance at school functions and parent meetings, support of homework policy, reading information sent home from the school, and communication with our child's teacher. We further understand that in today's complex society, certain circumstances can arise in which school authorities reasonably determine that a child's attendance at the school poses an unacceptable security risk to the school. If such a determination is made, the school may require the immediate withdrawal of the student.

**Discipline and Conduct:** The school shall have authority to require our child to comply with all school policies as contained in the Student/Parent handbook. We agree that we will fully cooperate with the school in maintaining the highest standards of civility for our child. We understand that the decision of the Administrator in all matters of student discipline is final. We further understand that our child's continued unacceptable behavior could result in expulsion from school. Corporal punishment (paddling), especially for K-6 students, is possible with parent permission.

**Damages:** We will pay for damages caused by our child.

**Activities:** We give permission for our child to participate in all school activities.

**Liability:** We release Riverside Christian School of all liability, except negligence, while our child is under school care and responsibilities.

**Grievances:** We pledge our loyalty to the aims and ideals of of the school, and will bring any and all questions and concerns directly to the appropriate teachers that they may be properly considered by those in authority. Further questions and concerns are resolved using the Matthew 18 policy as written in the Student/Parent Handbook.

**Financial Agreement:** We agree to fulfill all financial obligations promptly. We understand that the tuition payment is to be made in compliance with the tuition plan offered WITH NO REFUNDS.

Further, in the event my child becomes ill or is injured while under school supervision, I give permission for school authorities to take the following steps:

- 1. Contact a parent of the child and follow his/her instructions, or
- 2. Contact the child's physician and follow his/her instructions, in the event neither parent can be reached, or
- 3. Use their own discretion in contacting a properly licensed physician and to follow his/her instructions if the child's own physician cannot be reached.

If, in the opinion of a properly licensed and practicing physician, my child needs medical or surgical servi9ces which require my consent before being supplied, and I cannot be reached, I hereby authorize, appoint, and empower the Administrator, or his designee, on my behalf to supply such written or oral authorization should it

be required. Further, I release the Administrator, or his designee, and Riverside Christian School from any liability which might arise from the giving of such authorization, it being my desire that my child be furnished with such medical or surgical services as soon as reasonably possible after the need arises.

Riverside Christian School reserves the right to refuse any application, or to dismiss any child at any time, for unacceptable work or any other reason it deems necessary. Neither this application nor payment of fees is considered binding upon Riverside Christian School.
